

# Tenby Sailing Club Dinghy Park

## Dinghy Park Regulations

### 1. Use of the Dinghy Park:

- a) Use of the Dinghy Park is restricted to members, temporary members and honorary members of the club.
- b) Every Dinghy may be required to display a tag, allocated by the committee, on the front of the boats launching trolley or trailer. Tags may be issued on receipt of payment.
- c) Spaces may only be used on acceptance of a completed application form, the appropriate fee and any other amounts owing to the club.
- d) Any boat that is parked in the Dinghy Park without permission shall be removed from the Dinghy Park at the owner's expense.
- e) Abandoned boats identified by the committee will be removed from the Dinghy Park and if necessary sold to recover costs owing to the club. The club will follow the RYA 'guidance note on abandoned boats and trailers'. [Click Here](#) for link to this document on the RYA site.

### 2. Liability:

- a) The club accepts no liability in any way whatsoever for any loss or damage to boats stored on the premises or any third-part loss or damage caused by them.
- b) Neither the club nor any person acting on the authority of the club shall be liable for any loss or damage to any boat or other equipment that is moved in accordance with, or as a consequence of, the TSC Dinghy Park regulations.
- c) Owners are advised to ensure that they are adequately insured for such risks during the period of storage.

### 3. Conditions of use:

- a) Boats will be initially allocated a position in the Dinghy Park, but this may be changed during the year depending on usage levels.
- b) If a boat is clearly in an unseaworthy condition, the owner(s) may be given one month to either put it into sailing condition and use it or remove it.
- c) Owners of boats that are infrequently used may be asked to vacate their space.
- d) Any boat that is not actively used may be moved out of the Dinghy Park to another location.
- e) Boats may be temporarily moved to another location in the dinghy park for the duration of championship events held at the club.
- f) If the owner locks a boat or trailer to a fixed point in the Dinghy Park, a spare key must be lodged with the Dinghy Park master. Failure to do so may result in a lock having to be forcibly removed.
- g) All boats must have a name or sail number clearly marked on the exterior hull and this must correspond to the name or number given on the application form.

### 4. Charges:

- a) The charges for the use of the Dinghy Park will be set annually by the committee.
- b) If at any time, any charges owing to the club are in arrears, the committee shall be entitled to move the boat to a new location without being liable for any loss or damage to the boat howsoever caused.
- c) On acceptance of the application form and payment of all charges, the committee will allocate a suitable space and may issue a tag for display on the front of the Dinghy launching trolley or trailer.
- d) Dinghy park fees for 2019 will be due on the 1<sup>st</sup> January 2019 and on the same date each subsequent year.

### 5. Rates:

- a) The rate for a space in the Dinghy Park for 2019 is £80 per annum
- b) Temporary rates for visiting boats will be £15 per week
- c) Any boat in the Dinghy Park for a period greater than 3 weeks will be deemed non-temporary and will be liable for the full annual charge.
